The following criteria will apply for the award of the designation of Chartered Chemist of the Institute of Chemistry Ceylon.:-

GUIDANCE FOR REFEREES

Every candidate for the award of the status of Chartered chemist (C. Chem.) shall

C 1 be more than 25 years of age.

AND

C 2 (a) have passed parts I and II (A & B) of the Graduateship Examination conducted by the Institute of Chemistry, Ceylon at Honours Level.

OR

(b) have obtained a First or Second Class Honors Special Degree with Chemistry as the Principal subject from a recognized university.

OR

(c) have obtained a Bachelor's Degree of a recognized university with Chemistry as one of the subjects and at least a Masters Degree in a branch of Chemistry from a recognized university.

OR

(d) have obtained at least a Special Degree in Chemistry as the principal subject from a recognized university and acquired sufficient experience in the field of Chemistry acceptable to the Council for at least four years.

OR

(e) have obtained a Bachelor's Degree of a recognized university with Chemistry as a subject, has attained an acceptable level in Chemistry and has had sufficient experience and/or attainments in the Chemical Sciences acceptable to the Council for a period of at least 10 years.

OR

(f) have obtained any other equivalent qualifications acceptable to the Council,

AND

C3 have passed Part II (C) of the Graduateship Examination conducted by the Institute OR has an equivalent attainment acceptable to the Council,

AND

- able to demonstrate a high level of competence and professionalism in the practice of Chemistry and show his commitment to maintain his expertise for a period of at least 5 years subsequent to obtaining the qualifications and experience referred to in C 2 above.
- C 5 provide evidence of possessing one or more of the following at a level acceptable to the Council.

AWARD OF CHARTERED CHEMIST DESIGNATION

Every applicant seeking the award of a **Chartered Chemist** shall be a member or Fellow or an experienced practicing Chemist shall need to demonstrate a high level of competence and professionalism in the practice of chemistry and show their commitment to maintain their expertise. They will need to have at least five years of professional experience subsequent to a good enhanced first degree or can demonstrate an equal level of attainments such a person should provide evidence of possessing one or more of the following at a level of acceptance to the Council:-

- has specialist chemical skills relevant to their practice
- has in-depth knowledge of the specialist areas of chemistry
- has responsibilities based upon chemistry and has made a significant professional contribution.
- Demonstrates professionalism in the workplace
- has maintained chemical expertise through continuing professional development

The A & EP Committee would need strong evidence that their professional standards were already met to consider direct awarding of the designation of Chartered Chemist
