FCBG 2024.2: Re-registration fees for the Academic Year 2024

- 2.1. Following the release of the final results, a deadline of 4-8 weeks (decided by ABF) will be given for repeat students to re-register for an additional year. Re-registration should be done considering the number of credits that are required to be completed by the respective student as per the criteria and is compulsory in order to apply for the relevant examinations.
- 2.2. For students repeating the programme in their 5th and 6th year, the re-registration policy will be as follows:

No. of Credits repeated	Amount to be paid
≤10	Rs. 16,500
≤20	Rs. 33,000
≤30	Rs. 49,500
>30	Rs. 82,500

- 2.3. This payment scheme is not valid for students with academic skips.
- 2.4. From the 7th year onwards, a re-registration fee of Rs. 10,000 will be applicable irrespective of the number of credits to be taken
- 2.5. In addition to the re-registration fee, the entrance fee per level and exam fees per credit should be paid.

FCBG 2024.3: Terms and conditions

- 1. An administrative fee of LKR 50,000 will be applied for withdrawals made before commencement of the programme.
- 2. The amount to be paid will be significantly less for payments made under the one-installment scheme.
- 3. A discount of Rs. 25,000 will be entitled for the Registration Fee of students enrolling for the weekday group.
- 4. A fee of Rs. 50,000 will be charged for students transferring from the Weekday group to the Weekend group. It must be noted that lectures will be held on Friday afternoons, Saturdays, Sundays and during any public holidays, for the students enrolled in the weekend group, as deemed suitable by the Institute.
- 5. The Tuition Fees (Theory & Practical) may be subject to government taxes.
- 6. Upon completion of the programme, a mandatory fee for Life Membership of the Institute of Chemistry Ceylon (Rs. 20,000/=) must be paid.
- 7. Upon completion of the programme, a mandatory fee for Alumini Life Membership of the Institute of Chemistry Ceylon (Rs. 2,500/=) must be paid.
- 8. A nominal fee will be charged for the convocation.
- 9. All students continuing the program for more than four years, and thus requiring an extension of their registration, should pay a re-registration fee depending on the length of the programmes for which they are re-registering as per the financial criteria pertaining to the year of re-registration.
- 10. In the event that a student extends his registration without being entitled to an official academic skip by the Academic Board, he/she is required to pay the re-registration fee.
- 11. In the case that a student sits a repeat examination, they are required to

pay a per-level entrance fee as well as a per-credit examination fee. Where a student skips a particular paper, the skipped examination will also be considered as a repeat examination and the aforementioned fee structure for a repeat examination will apply (Annexure 1).

- 12. Library losses, laboratory breakages or any other losses will be deducted from the refundable deposit.
- 13. In the event that any candidate registered for a research project, literature survey or internship, withdraws from the relevant course, he/she will be charged an amount allocated for that respective course.
- 14. The payments stated above are subject to change; the final decision will be undertaken by the Council of the Institute of Chemistry Ceylon.
- 15. If the necessary payments for the relevant year are not made on time, the registration of the student will be terminated.
- 16. No active student is allowed to use his/her refundable deposit for payment purposes prior to graduation.
- 17. The College of Chemical Sciences has the right to conduct online teaching and assessments. All enrolees should have facilities (ex: a PC/Laptop with a working microphone and a camera, a smartphone with a working microphone and a camera, and a stable internet connection in order to participate in online learning activities.
- 18. All enrolees are bound to the FCBG 2024 which illustrates the criteria for payment structure, terms and conditions and refund policy, and should follow the re-registration policy pertaining to the year of continuation in the event that he/she needs to extend his/her registration.
- 19. A prospective student must agree with the above terms and conditions upon enrolling for BSc Hons in Chemical Science or Graduateship Programme in Chemistry (GIC) at the Institute of Chemistry Ceylon.
